This growth rate is slightly faster than what was observed in 2017 (4.2 percent) and the same as 2016 (4.6 percent). After a period of relatively fast growth in 2014 and 2015 during the implementation of the Affordable Care Act, 2018 was characterized by slower and stable growth that continued from 2016 and 2017.
